Appointments** – **Motion** by S. Mack, 2nd by D. Mack and carried to appoint Robert Mack, Larry Colvin and Ed Groholski to the Township Board of Review for 2-year terms. **Fire Department Application** - **Motion** by D. Mack, 2nd by Eyre and carried to accept Gary Wiescholak's application to the Fire Department effective 12-8-2022. **Deputy Treasurer** – Susan Mack has appointed Sara Converse as Deputy Treasurer effective 12-8-2022. **Motion** by D. Mack, 2nd by Eyre and carried to set the Deputy Treasurer's hourly wage at \$15.00 per hour. **Lost Time Wages** – **Motion** by D. Mack, 2nd by S. Mack and carried to reimburse Paul Walker lost time wages (\$350.00) for 12-7-2022 while he was at the Calhoun Street cleanup. This lost time wage cost will be applied to the overall cleanup cost and reimbursed to the township. **Adjournment:** The meeting was adjourned at 7:17 p.m. by Supervisor Eyre.
